

Bradford White Limited Warranty for:

Brute XTR Commercial Condensing Gas Boiler

Models BNT2H0399, BNT2H0500, BNT2H0650, BNT2H0800, BNT2H0999 and BNT2H1500

This limited warranty is effective as of the date of installation or 6 months after the date of manufacture, whichever is first.

Date of manufacture can be determined by the serial number.

Bradford White shall, at its option, modify, repair, or exchange the defective item. Bradford White shall have the option of having the item returned, FOB its factory, or to make field replacement at the point of installation. Bradford White shall be entitled to inspect the product prior to repair or replacement.

FIRST YEAR – LIMITED WARRANTY: Bradford White warrants that all parts of the Brute XTR condensing water heater (including circulating pump when supplied by Bradford White) to be free from manufacturing defects in materials and/or workmanship and at its option will repair or replace, any defective component for one year.

SECOND THROUGH TENTH YEAR – NON-PRORATED LIMITED WARRANTY FOR PRIMARY HEAT EXCHANGER: Bradford White warrants the primary heat exchanger to be free from manufacturing defects in material and/or workmanship, and at its option will repair or replace, any defective heat exchanger for ten years.

FIRST THROUGH TWENTY-FIVE YEAR NON-PRORATED LIMITED WARRANTY FOR HEAT EXCHANGER: Bradford White warrants the heat exchanger from "Thermal Shock" for twenty-five years.

EXCLUSIONS:

The liability of Bradford White shall not exceed the repair or replacement of defective parts and does not include any cost for labor to remove and reinstall the alleged defective part, transportation to or from the factory, or any other materials required to make the repair.

This warranty does not cover failures or malfunctions resulting from:

1. Failure to properly install, operate or maintain the boiler in accordance with our published Installation, Operation and Maintenance Manual or Users Information Manual provided with the product;
2. The workmanship of any installer;
3. Abuse, alteration, accident, fire, flood, negligence, or act of God;
4. Damage or failure due to hard water scale buildup on the inside of the heat exchanger;
5. Sediment or lime buildup, freezing, or other conditions that cause inadequate water flow;
6. High velocity water flow in excess of published heat exchanger designed flow rates;
7. Use of non-factory authorized parts or accessories in conjunction with the boiler;
8. Components that are part of the heating system, but not supplied by Bradford White as part of the boiler;
9. Contamination of combustion air including dust, dirt, environmental particles and construction particles;
10. Contamination of boiler components from chemicals stored in the mechanical room;
11. The repair or replacement of parts or components without proper approval.

PURCHASER'S RESPONSIBILITIES

The following are the responsibility of the purchaser:

1. Bradford White Corporation requires the boiler be maintained in accordance with the User's Manual and the Installation Operation Manual to avoid premature failures and to keep the unit operating at peak performance;
2. All system components must be kept in good working order;
3. Any condensation lines must be kept free and clear to assure proper drainage;
4. Annual visual inspection of venting system for leaks or sagging.

LIMITATIONS OF LIABILITY:

This is the only warranty given by Bradford White Corporation. No one is authorized to make any other warranties on Bradford Whites' behalf. THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY. BRADFORD WHITE EXPRESSLY DISCLAIMS AND EXCLUDES ANY LIABILITY FOR CONSEQUENTIAL, INCIDENTAL, INDIRECT OR PUNITIVE DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY. This warranty gives you specific legal rights, and you may also have other rights, which may vary, from state to state and by province.

WARRANTY CLAIMS:

For prompt parts warranty claims, contact your installer with the following information: Model number, serial number (located on the rating plate) and date of installation. The installer will notify the wholesaler from whom the boiler was purchased for instructions regarding claim. All alleged defective part(s) must be returned through trade channels and replacement part(s) will, if warranty conditions are met, be provided by Bradford White Corporation through the wholesaler.

This Warranty is extended to the first retail purchaser of the boiler and only to a boiler that has not been moved from its original installation site.
